#### **UTRA CELEBRATES ANNIVERSARY AT ANNUAL MEETING**

UTRA kicked off its 30th anniversary celebration at the annual meeting held at the Belmont Country Club on June 11.

The meeting opened with a presentation honoring the past presidents of UTRA and the MUO retirees association, which was assembled by the UTRA 30th anniversary committee, chaired by Lynn Hutt.

Matthew Schroeder, interim president, gave the keynote address. Schroeder began by noting that like members of UTRA, he too had deep roots at The University of Toledo and the former Medical College of Ohio, spending half of his career to date on each campus. His talk provided an overview of activities at

the University over the 13 months of his interim administration, and how he had worked to transition the University to its new president, Dr. James Holloway, who began his tenure on July 15.

Schroeder stated that among the University's achievements of the last year was receiving the Carnegie Foundation Research I classification, making UT the only university in northwest Ohio with such a designation. The process to achieve Research I status required many years of building the research endeavor. "This could not have been done without our faculty," Schroeder added.

He noted that one of the most important UT research facilities is the Lake Erie Research Center, which has been at the forefront of efforts to protect the region's water supply. Schroeder said a clean water source will lead to a resurgence in northwest Ohio's economic development and ensure healthy living conditions.

# **NEWS FROM COLUMBUS**

#### **STRS OHIO**

The composition of the STRS board of trustees is changing. As conferees from the Ohio House and Senate met late June to reconcile their different versions of the state budget bill, a last-minute provision regarding STRS was inserted, reportedly by representative Adam Bird (R), chair of the Ohio Retirement Study Council (ORSC).

The provision changes the makeup of the board from seven elected members (five contributing teachers and two retired members) and four appointed members to three elected members and eight appointed members. Two of the elected seats will be for active members and only one for a retiree member. Four new seats will be filled with additional appointed members. Currently, the Governor, Treasurer of State, and Director of the Department of Education and Workforce each appoint one member, and the Speaker of the House and the President of the Senate jointly appoint one. The four new appointed members will be chosen by the Chancellor of Higher Education, the Speaker of the House, the President of the Senate, and a second member by the Treasurer of State.

Elected members currently on the board will be able to finish their term, but once those terms end, only three seats will be refilled. Also, elected members (members with contributions in the pension fund) will no longer be able to serve as either board chair or vice chair. The newly appointed members can have no such contributions on deposit in the fund. Two other items in the provision specify that appointed members serve at the pleasure of those who appoint them, and appointed members are to receive \$200 for each regular board meeting they attend plus healthcare.

The motivation for these changes seems to stem from legislative concerns over the turmoil and unfavorable publicity surrounding STRS, and by the possibility that elected board members could vote to hire an outside company with a limited track record and an unproven investment strategy to manage much of STRS's investments.

At its June meeting, the board voted to select Steven C. Toole as the next permanent Executive Director of STRS Ohio. The vote was 6-5 in favor. He started July 14, and replaced Aaron Hood, who had served as interim Executive Director since November 2024. Toole previously managed the public pension

systems in North Carolina and was most recently a senior product manager for Principal Financial Group in Iowa.

In other action, the board approved healthcare premiums for calendar year 2026. Aetna will continue to be the plan administrator for all enrollees and CVS Caremark will continue to provide prescription coverage. Benefit recipients receiving the maximum subsidy will have a monthly premium charge of \$37. Non-Medicare recipients receiving the maximum subsidy will pay \$340 monthly. Additional details are available on the STRS website.

Meketa, the board's investment consultant, shared results of its quarterly report on STRS's investment performance for the period ending March 31, 2025. They reported that for the fiveyear period as of March 31, 2025, STRS posted an annualized net return of 10.98% versus the total fund benchmark of 10.54 percent. Additionally, STRS's trailing five-year net return ranked near the top 20 percent of peers while exhibiting less risk than the median of Meketa's public defined benefit plan universe. The board also voted to adopt the system's operating and capital budgets for fiscal year 2026. The operating budget totals \$129.1 million, a 9.2 percent increase over the last fiscal year budget. The capital budget totals \$7.6 million, which is 10.9 percent lower than last year.

#### **OPERS**

OPERS has released its annual financial reports for the year ending December 31, 2024. The Comprehensive Annual Financial Report (CAFR) and the abbreviated Popular Annual Financial Report (PAFR) provide a detailed look at the financial, investment, actuarial and demographic details of the pension system. Both are available for review at opers.org.

Included in the reports:

•The OPERS defined benefit plan fund ended 2024 with a market value of \$106.9 billion.

The funded status of the pension fund was 82.8 percent. The unfunded liability of \$22.1 billion was expected to be funded within 15 years (well within the 30-year funding window).

Membership reached more than 1.32 million, including 221,498 retirees, 316,214 active members and 785,889 inactive members.

- OPERS made pension benefit payments of \$7.5 billion, up from \$7.2 billion in 2023.
  - Healthcare expenses (net of healthcare

# SATELLITES AUXILARY VOLUNTEERS CELEBRATE 50TH ANNIVERSARY

The Satellites Auxiliary Volunteers of The University of Toledo was founded in 1975 at the then Medical College of Ohio. In 2025, the group is celebrating 50 years of service — its golden anniversary.

The Satellites' purpose is to support The University of Toledo through education, service, volunteerism, research, and community outreach. For half a century, its mission has endured through unwavering dedication to these ideals.

Over the decades, the organization has adapted to many changes from the Medical College of Ohio to the Medical University of Ohio and now The University of Toledo while remaining steadfast in its support. Satellites' volunteers are among the University's closest allies, donors, and community advocates.

Since 1975, the Satellites have donated about \$4 million and millions of service hours to UToledo. They provide annual student scholarships and have helped fund specialized equipment

for Cardiac Rehabilitation, Radiation Oncology, the Morse Center, the Emergency Department, and the Kobacker Adolescent Psychiatric Hospital.

The Satellites also collaborate with other University groups, including UTRA, on fundraising and outreach. Volunteers and UTRA members continue traditions such as providing stuffed animals to children in UTMC and Kobacker, creating monthly tray favors for patients, and supporting the College of Medicine and Life Sciences' S. Amjad Hussein Medical History Lecture Series.

receipts) for 2024 were \$0.5 billion, about the same as the previous year.

- The OPERS defined benefit fund returned (net of fees) 8.82 percent, above the assumed rate of return of 6.9 percent. The healthcare portfolio returned 10 percent, above its assumed rate of return of 6 percent. Total portfolio return, combining the returns of the pension and healthcare funds, was 9.08 percent.
- For retirees in the traditional plan, the average age was 71.5 years, the average service credit in years was 23.4, and the average annual benefit was \$33,369.
- Last year, OPERS had 80 members who were more than 100 years old, with the oldest being 109.
- OPERS is good for members and good for Ohio. It is the largest public pension fund in the state,

and the 14th largest in the United States. For every dollar received from public employers in 2024, \$3.04 was returned to the Ohio economy through pension and healthcare payments made to retirees. OPERS invests \$2.1 billion of assets with Ohio-based companies.

Cost-of-living adjustments (COLAs) have been determined for 2026. Those retirees with a benefit effective date prior to January 7, 2013, will receive an automatic 3 percent COLA. The COLA for those who retired after that date is based on the CPI-W from the end of June 2024 to the end of June this year, with a maximum adjustment of 3 percent. For 2026, the OPERS CPI-based COLA will be 2.6 percent. OPERS uses the same index as Social Security, but the time period is different, so the adjustments may not always match up.

#### **UTRA: 30 YEARS OF WORK AND NOT READY TO RETIRE**

Editor's Note: This is an updated version of the article that appeared in the Spring 2020 *Tower Talk* that detailed the history of UTRA at 25.

"The UTRA organization is a valuable, indeed critical, organization for the University. Its membership provides an active living memory of personal contributions to the building of The University of Toledo.... There is no substitute for the knowledge that the faculty and staff retirees carry with them about what the University has meant to the many lives of the students and employees of the University, as well as the citizens of Toledo and northwest Ohio."

With these eloquent words, UTRA President Dr. Richard Perry summarized the significance of the organization in an article appearing in *Tower Talk* in 2003. As we celebrate UTRA's 30th anniversary in 2025 (and what would have been the Medical

University of Ohio Retirees Group 35th anniversary), it seems like an appropriate time to take a step back and examine the legacy of these groups in serving those who served the University through a lifetime of work.

The roots of UTRA date back to 1994, when initial discussions with interested retirees were held. The organizational meeting for the group was held on February 28, 1995, in the Schmakel Alumni Center. It was decided then that the group should be named UTRA, and following a series of additional planning meetings, bylaws for the

group were approved on April 17. The formation of the group was announced on May 15, and all retirees were invited to a brunch in the Driscoll Center on June 11 (coincidentally, the same date as the UTRA annual meeting in 2025). More than 125 people attended that brunch, and its success led to scheduling a holiday brunch in December in the Ingman Room of the Student Union (another tradition that continues today).

The mission of the organization as stated in the bylaws was to work for the well-being of its members by providing or promoting: ways to improve the economic conditions of members, ways to improve the health of members, opportunities for continuing service to the University, assistance or information to surviving spouses or family in the case of illness or death, social and recreational activities, and involvement in community volunteer activities.

The initial Retired Faculty/Staff Committee Roster included Jim and Marilyn Arbaugh, Art and Virginia Black, Jim and Eleanor Brunner, Helen Douglas, Ed and Dorothy Ebert, Tom and Ellen Gibney, Lloyd and Betty Lapp, Leslie and Ruth Lahti, George Murnen, Bob and Mary Niedzielski, Richard Perry, Bob and Mary Schlembach, Willard and Nadine Smith, Stephen Spielberg, George and Jane Taoka, Jim Thomas, Lance and Naomi Thompson, and Bill and Joan Wiersma. The first officers were President James Brunner; Vice President Lance Thompson; Secretary Willard Smith; Treasurer George Taoka; Historian Lloyd Lapp; and members-at-large Bob Schlembach, Jim Thomas, Jim Arbaugh, Art Black, Helen Douglas and Stephen Spielberg.

Almost immediately, the UTRA board began

advocating on behalf of its members by asking the University administration to provide access to dental and vision care insurance — insurance then unavailable through the state retirement systems. In the fall, the University agreed to allow UTRA members to purchase such insurance at a group rate, a benefit that they retained until 2007.

After the busy first two years, UTRA settled into its work of assisting members and providing social activities. UTRA joined the Ohio Council of Higher Education Retirees, a statewide group that collaborates on issues of interest to all state

university retirees, particularly the benefits provided by STRS and OPERS. In May 1998, OCHER held its first state conference in Columbus, with the theme of "Retirees Helping Retirees." UTRA's representatives to this organization (particularly Jim Lapp) have worked diligently over the past 30 years to monitor the actions of the state pension boards and to advocate on behalf of its members.

Dr. Richard Perry organized a project in 2000 in conjunction with University Archives to record oral history interviews with UToledo retirees. Working with faculty in the College of Education, the project encouraged retirees to record audio interviews that would detail important events in their careers and comment on their contributions to the University.

In 2004, UTRA undertook a major service project when it created the UTRA Scholarship Fund. The intent of the fund was to award scholarships to direct descendants of UTRA members or deceased members.

With the proposed merger of The University of Toledo and the Medical University of Ohio announced in 2006, the boards of UTRA and MUOR appointed a task force to see how the two groups might merge. In May, the task force report was accepted by the boards of both groups. Committees were appointed to look at specific issues, including benefits, social activities, finances and scholarships. On September 19, 2006, the merger became official. MUOR president Roberta Raeder expressed the sentiment of many when she stated in Tower Talk, "As retirees, we should be very proud of our gifts to the institution and should now carry these gifts forward to be a part of the evolution of this great institution — The University of Toledo."

Two Important charitable activities were undertaken in 2008 and 2009. In 2008, Augusta Askari asked each UTRA member attending the holiday brunch to bring a stuffed animal to be given to children admitted to the UT Medical Center to provide comfort in a time of stress. In 2009, UTRA agreed to purchase a plaque for the new Veterans' Plaza on the UT Main Campus. The initiative was spearheaded by Dr. Richard Perry, past UTRA board president.

The success of UTRA was recognized in 2012 when the organization was named UToledo Alumni Affiliate of the Year for the first time. It would be recognized as such three additional times — in 2014, 2019 and 2024. The first award was presented to the group at the groundbreaking for the William and Carol Koester Alumni Pavilion. It was noted that UTRA was one of the most active of alumni groups, with more than 40 events throughout the year. The scholarship funds (both the UTRA and the Medical College retirees scholarships) were also noted as a reason for the award.

In 2014, a new activity called Book Buddies was started. In 2015, *Tower Talk* included an article in honor of the 40th anniversary of the UTMC Satellites Auxiliary, which noted that the group had donated more than \$5 million and thousands of volunteer hours to MCO and UTMC throughout its history. In 2016, UTRA's new Facebook group was announced.

In addition to these historical mileposts, UTRA has offered countless seminars, lectures, social events and bus trips throughout its 30 years. The first bus trip was to Grand Rapids, Mich., in 2000. Since that trip, UTRA members have had the chance to visit Chicago, Washington, Boston,

Branson, Toronto, Cape Cod and Montreal, and most recently Mackinaw Island and Colonial Williamsburg. The bus trips have provided opportunities for UTRA members to experience travel companionship at reasonable prices.

Since celebrating its 25th anniversary in 2020, UTRA has continued its service to members. Educational programming continued throughout the pandemic by moving presentations to a virtual setting, including the annual wine tasting offered by Jim Sautter of Sautter's market, a firsthand account of 35 years of research in Egypt by UT retiree Dr. James Harrell, and a behind-the-scenes tour of the Toledo Zoo. Recent in-person programs have focused on subjects as broad ranging as the wreck of the Edmund Fitsgerald, a history of Civil War medicine, and a look at white supremacy groups.

In 2021, UTRA fought hard to maintain free oncampus parking for retirees, but was unsuccessful. UTRA leadership will continue to advocate for this benefit.

The Philanthropy Committee was established in 2024 to raise funds for UTRA projects. A "\$30 for 30 Years" special emphasis solicitation tied together UTRA's anniversary focused on raising money for the UTRA and Heath Science Campus Retirees scholarships. The Philanthropy Committee has also focused on raising funds for the UToledo Rocket Fuel Pantries.

A new activity group called the Pathfinders was established two years ago. The group meets twice a month for a pleasant but invigorating walk, followed by lunch at a nearby restaurant.

UTRA also participated in the celebration of the University's 150th anniversary in 2022. UTRA member Barbara Floyd, former university archivist, researched and wrote the 150th history of the University, An Institution for the Promoting of Knowledge: The University of Toledo at 150.

In addition, UTRA at 30 continues what is has always done: updating members on the state retirement systems through regular reports from the Ohio Council of Higher Education Retirees (including the most recent controversial events surrounding STRS); organizing the annual meeting and holiday brunch; and publishing the *Tower Talk* newsletter twice a year, which includes notices of the passing of colleagues, compiled by UTRA member Vicki Kroll.

As UTRA wraps ups its 30th anniversary celebration, members should be proud to know that the group continues its mission of service. Even if it has been working for 30 years, UTRA is not ready to retire!

On the downside, Schroeder noted that all academic institutions are facing strong headwinds, with economic pressures at both the federal and state governments. To ensure viable academic programs, the University has implemented a rigorous program review requirement, and some programs were merged or eliminated as a result of Senate Bill 1, which established minimum numbers of graduates per year. The law also included new limitations on how curriculum could be presented in the classroom.

Not only are academics undergoing rapid change, so too are athletics. Schroeder noted that the requirement to pay student-athletes for use of their images has meant that some are being represented by talent agents, who can take advantage of them. Schroeder said the University is focused on graduation rates to ensure student-athletes are successful in their post-university lives.

The University's physical environment has also undergone change over the past year.

In particular, the Academic House and the International House have been demolished, and the locations turned into green spaces. When enrollment stabilizes, new housing built with public-private partnerships will replace these residence halls.

The primary goal for the immediate future, Schroeder said, was increasing enrollment. This will be difficult with new federal regulations governing international students, who currently make up 10 percent of the student population. The University is going to focus recruitment on the local region and transfer students. "Our role as a regional public university is to educate and keep young people in our state," he said.

After Schroeder's speech, UTRA President Andy Jorgensen thanked the outgoing UTRA board members for their service, including Laurie Flowers and Tom Mehalas. President Jorgensen was also serving his last term on the board.

#### IN MEMORIAM

Sharon M. (Myers) Ahrens, Toledo, who volunteered with the Satellites Auxiliary, died Aug. 12 at age 94.

Dr. David C. Allison, Rossford, professor emeritus of surgery, died July 17 at age 83. He joined the MCO faculty in 1992 as professor and chair of surgery. He received tenure in 1996 and one year later received a joint appointment in the Department of Physiology and Molecular Biology. Allison retired from clinical practice in 2015 and from the University in 2017. He was rehired as director of the Advanced Microscopy and Imaging Center in 2017 and worked until 2023. Allison was named professor emeritus in 2024.

Dr. Harvard L. Armus, Toledo, professor of psychology who

taught for nearly six decades, died May 29 at age 96. He joined the UT faculty in 1960 and retired in 2009. Armus continued to teach part time until 2019.

Guy T. Barone, Toledo, died June 6 at age 78. He received a law degree in 1972 and later returned to his alma mater to teach law classes.

Dr. Martha J. (Johnson) Pituch, Sylvania, MCO professor of nursing, died June 1 at age 92. She joined the School of Nursing when it formed in 1977. Pituch had a passion for bringing public health to the underserved. During the 1980s, she developed specialized programs for children with asthma and their families with the American Lung Association of Toledo. Also during the 1980s, Pituch was an early champion for HIV/ AIDS patients and their families, forming a support network. In 1985, she founded a nursing clinic to provide primary care for the homeless and mentally ill; that clinic still operates at the Cherry Street Mission. Her pioneering work in public health nursing garnered numerous honors, including the Golden Lamp Award from the Toledo District Nurses Association, the Compassionate Hero Award from the Multifaith Council of Northwest Ohio, the Nursing Leadership Award from the Northwest Ohio Nurses Association, and a National Jefferson Award for Public Service.
